Funds provided by the foundation shall not be used to carry on propaganda or otherwise attempt to influence legislation, or to engage in political campaign activities, or in any other manner that is prohibited by Federal, state, or local law. Further, your organization shall not, directly or indirectly, engage in, support or promote violence or terrorist activities.
5. Accounting Requirements. Your organization will maintain records of receipts and expenditures adequate to verify proper use of this grant during, and for five years after, expenditure of the grant funds. Such records will be made available to the foundation for audit upon our request.
6. Tax-Exempt Status. Your organization is described under IRC § 501(c)(1) or (3), is not a private foundation within the meaning of IRC § 509(a), and is classified as a public charity under IRC § 509(a)(1) or 509(a)(2) or as a Type I, Type II, or functionally integrated Type III supporting organization under IRC § 509(a)(3). You will notify us immediately of any change in your tax status.
7. No Earmarking. Your organization confirms that the activities funded by this grant are under its complete control. Your organization also confirms that it has and will exercise control over the process of selecting any secondary grantee or contractor, that the decision made or that will be made on any such selection is completely independent of the foundation and, further, that there does not exist any agreement, written or oral, under which the foundation has caused or may cause the selection of a secondary grantee or contractor.
