## **President's Column**

## Getting to Know the Arlington-Fairfax Chapter (Part 4)

## **Junior Chapter & Youth Activities**

Welcome to the fourth installment of "Getting to Know the Arlington-Fairfax Chapter." In this installment I am going to present to you information regarding the Chapter's Junior Chapter and its youth activities. Our children, grandchildren, and following generations are the future of shooting sports and this column will describe some of the ways the Chapter is providing exciting opportunities to get more youth involved in a variety of Chapter activities.

#### **Environmental Sciences Scholarship**

In 1993, the ARL-FX IWLA board of directors established the Environmental Sciences Scholarship as a means of demonstrating the Chapter's concern for the environment and to provide financial assistance to college students of Arlington, Fairfax, and Prince William Counties. The purpose of the scholarship program is to help ensure the continued involvement of the rising generations in the protection and improvement of the environment. The scholarship is paid directly to the student's institution of higher education.

At its inception, the scholarship was designed to provide a student with \$750 per year in tuition assistance

#### **IWLA Mission**

for up to four years, in support of their undergraduate degree in environmental sciences or a related field.

In 1999, the board of directors increased the annual scholarship to \$3,000 per student, per year. In 2014, the board of directors recognized the increasing costs of higher education and increased the scholarship grant, beginning in 2015, to its current level of \$5,000 per student, per year. Thus, the Chapter commits a total of \$20,000 every year to its new and returning scholarship winners.

The process for selecting a senior high school student for the scholarship is performed by an independent committee. Every April, the Chapter's scholarship committee reviews the student applications submitted and makes its scholarship recommendation to the board of directors on the basis of the applicant's academic achievement, character, financial need, and environmental activities and achievements.

In August 2020, the board of directors approved a proposal to give the Environmental Sciences Scholarship winners a free student membership to the ARL-FX Chapter for the entire time period they are receiving the scholarship.

#### **ARL-FX Junior Chapter**

The Arlington-Fairfax Junior Chapter of the Izaak Walton League of America was established in 2016. The Junior Chapter consists of many youth shooting programs and it has a membership of approximately 200 under the age of 18, who actively participate in a variety of activities sponsored or supported by ARL-FX. The popularity of the Junior Chapter is demonstrated by its membership. If the Junior Chapter were a separate chapter of the IWLA, it would be one of the largest chapters in the nation. Membership in the Junior Chapter is required of all youth participating in organized shooting sports activities (archery, air rifle & pistol, shotgun, and small bore) at the Chapter. The Junior Chapter is administered by a ninemember board of directors, elected annually from among the Junior Chapter's membership. #### **Youth Activities**

#### Academics, Integrity, Marksmanship (AIM)

The Chapter started a youth trapshooting team in 2014. Each spring, youth ages 12 to 18 participate in a semicompetitive program held at the ARL-FX trap range on Saturday afternoons. AIM is the official youth program of the Amateur Trapshooting Association (ATA). #### **Youth Air Rifle Program**

The Potomac High School Rifle League (PHSRL) is a precision air rifle association of high school rifle teams in the northern Virginia area. Because most of the teams are from Fairfax and Arlington Counties, ARL-FX sponsors and provides the home range for many of these local high school teams. Shooters use precision air rifles in three positions (prone, kneeling, and standing) with peep sights, firing a 4.5 mm (.177 cal.) pellet at a target 10 meters from the shooter. For those who wish to shoot but their high school does not sponsor a team, they can join the Chapter's Mavericks team.

#### **Smallbore**

In 2022 the Sills Air Range was redesigned, providing it with the capability to convert part of the range to safely shoot precision smallbore (.22) rifles 50 feet from Megalink electronic targets.

Shooting disciplines: Only smallbore precision rifles shooting from a distance of 50 feet, using either 3-postion or prone are used, and no smallbore pistol is allowed. Only subsonic competition ammunition is allowed. Athletes desiring to shoot on the smallbore set-up must provide a qualifying score from a validated score source. Acceptable score sources include published match results from CMP, USAS, NRA, NCAA, ISSF, PHSRL, IWLA, and other official organizations. Athletes providing only prone scores may only shoot from a prone position. The athlete should contact their coach for more information.

#### **Adaptive Shooting for Youth**

The Sills Air Range has the ability to work with disabled and physically challenged youth, to allow them the ability to shoot precision air rifles, either by themselves or as a member of one of the shooting teams. Under the supervision of highly experienced Chapter coaches, wheelchair adaptive shooters and youth with physical

#### **NoVA Sharpshooters Youth Pistol Program**

The NoVA Sharpshooters youth pistol program introduces junior athletes to the sport of international air pistol. This shooting discipline uses an air pistol with iron sights firing a 4.5 mm (.177 cal.) pellet at a target 10 meters from the shooter. As junior athletes develop, they will advance from beginner (sitting supported) to intermediate (standing supported) and finally advanced (standing unsupported). The program is open to junior athletes 10 to 18 years of age. Payment of the Sills Air Range consumables fee and membership in the Junior Chapter of ARL-FX are required for participants. ## **Zhang Suspension Explained**

In accordance with Article I.3 of the Chapter's bylaws, the following motion was made, properly seconded, and approved unanimously by the directors and officers present at the July 11, 2023, board of directors' meeting. In accordance with Chapter bylaws, this suspension is effective immediately and is further subject to approval by the Chapter membership at the August 15, 2023, general membership meeting.

"That Yunqiu W. Zhang be suspended through the rest of the calendar year, from now until December 31, 2023. If she renews her membership, she will be allowed back on the Chapter on January 1, 2024."

The reasons for the suspension are as follows:

- 1. Violation of Chapter Ground Rules 2 (Wearing Range Badge), 3 (Guests), and 5 (Minors), and Target Archery Range Rule 3 (Age). On May 27, 2023, Ms. Zhang left a minor guest alone at the Chapter to shoot target archery. The minor guest did not have a range badge. When informed she needed to pick up the minor guest, she instead sent another non-Chapter member to retrieve the minor. Ms. Zhang was informed to contact the Chapter president regarding this breach of range rules for further clarification.
- 2. Violation of Chapter Ground Rule 7 (Misuse). By May 30, 2023, no correspondence had been received from Ms. Zhang after she had been instructed, on May 27, 2023, to contact the Chapter president. The president then sent her a letter that instructed her to come before the board of directors on June 6, 2023, to discuss the event. On June 5, 2023, Ms. Zhang was re-informed via e-mail from the Chapter president she was required to attend the June 6, 2023, board of directors' meeting. Ms. Zhang did not attend the board of directors' meeting, but the Target Archery logbook indicated she was on the property at the time of the meeting.
- 3. On June 6, 2023, the board of directors voted to temporarily put Ms. Zhang's membership on hold until she could discuss the events leading to the temporary hold. A special board of directors' meeting was scheduled for June 20, 2023, to discuss the events with Ms. Zhang.

- 4. Ms. Zhang attended the June 20, 2023, special board of directors' meeting, where the circumstances and reasons leading to the board of directors' decision was provided, and Ms. Zhang was able to respond to the accusations. Ms. Zhang turned over her range badge and she was informed she was not allowed to use any Chapter ranges until a final board of directors' decision was made regarding her membership.
- 5. On June 23, 2023, the board of directors informed Ms. Zhang via letter they believed she understood the Chapter's position, the violations that had occurred, and the reason she was called before the board of directors. The letter stated the board of directors felt no further disciplinary actions were necessary, and she could retrieve her range badge at the July 11, 2023, board of directors' meeting, at which time full access to the Chapter facilities would be restored.
- 6. Violation of Chapter Ground Rule 2 (Wearing Range Badge) and Target Archery Range Rule 5 (Guests). On June 24, 2023, Ms. Zhang and a minor guest were observed utilizing the Target Archery range. Ms. Zhang did not have a range badge and was therefore not allowed to utilize the range. Ms. Zhang was notified to vacate the range by the designated director for Target Archery in accordance with Target Archery Range Rule 9.
- 7. Given the repeated disregard of Chapter and Target Archery rules, the board of directors voted to suspend Ms. Zhang's membership at the July 11, 2023, board of directors' meeting.

August 15, 2023—General membership meeting. BOD motion to suspend Ms. Zhang's membership was presented to the members in attendance. Ms. Zhang provided more information to the membership about incident. Members asked questions and spoke to Ms. Zhang.

 A member moved to suspend Ms. Zhang's membership for the remainder of 2023. Motion properly seconded by a member and unanimously approved by all members present.

## Fairfax County Supervisors Visit ARL-FX Chapter

On July 22nd, the Arlington-Fairfax Chapter officers and board of directors welcomed Fairfax County Supervisor Kathy Smith (Sully District) and Supervisor James Walkinshaw (Braddock District) to the Chapter. Supervisor Smith represents the district where the Chapter is located and had previously visited the Chapter in 2017. Supervisor Walkinshaw was making his first visit to the Chapter.

The visit began at the field house with the introduction of the Chapter's officers and directors, followed by individual introductions of attending Scouts and Troop leaders. Chapter Vice President Chris Rose gave a presentation that covered the history of the Chapter and its facilities, from its Centreville inception in 1952 to the Chapter as it exists today. Supervisors Smith and Walkinshaw asked some very insightful questions that demonstrated their strong interest in the Chapter and its members.

Following the briefing, the supervisors were escorted to the Air Rifle range by Chapter President Pamela Meara and Mr. Rose where they were greeted by Range Director Keith Kuck. Mr. Kuck provided an interesting overview of the range's history and technologically advanced capabilities, also describing the many students and adult shooters who regularly practice there. Brian Leppert, coach of the Lake Braddock air rifle team was also present with members of the school's air rifle team, who demonstrated their advanced shooting skills. A spirited Q&A between the supervisors, Mr. Kuck, Coach Leppert, and the students led to good information exchanged and laughter among the group.

The next stop was the Field Archery indoor target range where the supervisors met Field Archery Director Dick Riemer, Target Archery Director Jeff Del Vecchio, and Cub Run Archers President Bob Walla. During this visit, the supervisors were introduced to the Chapter's two archery disciplines and related topics that included the Chapter's role in Fairfax County's Deer Management Program. Supervisor Walkinshaw picked up a bow and arrow and, under the direction of Mr. Walla, quickly zeroed in on the bullseye of a target placed at 15 yards.

The Rifle-Pistol range was next on the itinerary and the supervisors were greeted by Range Director Bruce Crandlemire and Director-at-Large Bob Hamilton. Mr. Crandlemire has known Supervisor Walkinshaw since he was a youth, so it was an enjoyable reunion for both men. After receiving a briefing on the range and firearm safety, both Supervisor Smith and Supervisor Walkinshaw sat

down, rifled-up, and started shooting at the steel targets down range. Shortly thereafter, and under the expert instruction provided by Mr. Hamilton, the constant ringing from bullets hitting the steel targets was being heard. Both supervisors shot so well, extra time was spent at the range and Supervisor Walkinshaw was just as accurate when he switched to a rifle with a sound suppressor.

The final stop of the day's visit was the Skeet & Trap range, where the supervisors met Range Director Bob Brino. Mr. Brino discussed the Chapter's S&T ranges and explained the extraordinary popularity of skeet and trap among members of all ages. He also explained the environmental care and maintenance that made the Chapter's S&T ranges "the cleanest outdoor shooting ranges in Virginia." Mr. Brino also discussed the Chapter's premier trap fundraising events, Crush'n Clays and the Tunnel to Towers tournaments, which demonstrate the Chapter's deep philanthropic commitment. Finally, after receiving expert instruction from Mr. Brino, Supervisor Walkinshaw destroyed a clay on only his third shot. Based on the supervisors' strong showing at the shooting ranges, some observers suggested the elected officials might be "naturals" with long guns.

As evidence of the day's success for all participants, the supervisors' visit, scheduled for two-hours, lasted 2½ hours.

Reflecting on her Chapter visit, Supervisor Smith said, "It was great to receive an invite to visit the Izaak Walton League facility and view the chapter operations and get to use the outdoor shooting range. It had been several years since my last visit and I appreciated the opportunity to reconnect with the membership. I'm impressed with the League's conservation efforts and environmental advocacy and glad that the Arlington-Fairfax Chapter is in the Sully District."

Supervisor Walkinshaw added, "Spending an afternoon with Supervisor Smith and the IWLA team in the Sully District was a pleasure! Although we didn't have time to try everything on the campus' extensive list of activities, I look forward to returning and learning even more about the conservation work, and how we can continue to expand the County's partnership."

On behalf of the Arlington-Fairfax Chapter's 2,200 members, the officers and directors thank Supervisor Smith and Supervisor Walkinshaw for visiting and learning about the many sporting and conservation activities enjoyed by adult and youth members.

#### ARL-FX IWLA Cub Run Archers



For those Chapter members who are interested in competing in Virginia Bowhunters Association (VBA) archery events, the Chapter established a VBA group called Cub Run Archers so field archery tournaments could be held at

the Chapter. VBA is the representative for bowhunters throughout the Commonwealth of Virginia. Applications to join Cub Run Archers are available at the Field Archery range house. #### **Limited Broadhead Use on Outdoor Range**

The indoor and 3-D archery ranges are for **field tip use ONLY**, no broadheads are allowed on these ranges. The
outdoor archery range does provide broadhead targets,
but only on the target butts marked in bright **RED** stating
"BROADHEADS OK."

## **Deer Processing Station**

For Chapter deer hunters who would like to process their deer, the deer processing station is twenty yards off the Field Archery deck. The area is lighted and has running water from a garden hose located by the deck entrance. You will need to bring trash bags with you for proper disposal of all parts of the carcass. When finished be sure to wash the area down completely, putting all remains in plastic bags before placing them into any dumpster. During cold weather, when finished be sure to drain the hose of water to keep it from freezing. Please leave the area cleaner than you found it.

#### **Restricted Transporting of Deer Carcass**

Whole deer carcasses and any parts containing brain and/or spinal cord tissues originating from Fairfax, Prince William, or Arlington Counties may only be transported to locations within DMA2 and DMA1 which includes Fairfax, Loudoun, Fauquier, Rappahannock, Culpeper, Orange, Clark, Page, Madison, Frederick, and Warren Counties.

These target butts are located at the crossbow station and include 20-, 30-, and 40-yard Rienehart walls (4' x 4' black target butts). There are also 2' x 4' target butts with **RED dots** that may be used for broadheads, and the **RED** cube dice at 50 yards. In other words, if there is a **RED "BROADHEADS** 



**NOT Allowed on IWLA Archery Range** 

**OK"** sign or **RED dots** on the block target butts, these may be used for broadheads. *All other targets are for field tips only*. This includes any 3-D targets that may be placed on the range.

*All core-drilling broadheads are strictly prohibited* on the Chapter archery ranges.

Damage to the target blocks and 3-D animals on the outdoor range has occurred. Anyone witnessing broadhead usage on these targets, please notify the Archery Range officer or any Cub Run officer.

As stated on the ARL-FX IWLA/Cub Run Archers Web site range rules (Section 11 PROHIBITIONS—https://www.cubrunarchers.org/range-rules.html):

"Anyone observed ... shooting broadhead-tipped arrows at other than targets expressly designed for that purpose will be referred to the Arlington-Fairfax Chapter, IWLA, board of directors for disciplinary action" with a recommendation they purchase the damaged target.

- Steel plates can only be used with .22 LR or nonmagnum centerfire handgun rounds with lead bullets (no jacketed ammo). Unless you have lead projectiles, you cannot shoot your 9 mm, .44 magnums, .45, ... at the steel plates.
- The only exception to this is the steel plates that are permanently at the 100-yard line; those targets can be shot with jacketed ammunition (rifle or pistol) from stations 7, 8, 9, or 10. Our rifle shooters enjoy those targets with their ARs and other centerfire rifles as well as handguns.

• Other than those permanently positioned at 100 yards, all other steel plates on the property are .22 or lead projectile, non-magnum handgun calibers only.

The Chapter's steel plates program is evolving, and we intend to make it as rewarding as possible, while still being safe, for all of the members to enjoy. Look forward to some new 100-yard steel targets in the near future. We'll provide updates as things change.

If you have suggestions, comments, or questions, do not hesitate to ask your RO or the Rifle-Pistol director.

We hope to see you on the range soon.

## **Rifle-Pistol Range**



Thank you for your interest in the Chapter's Rifle-Pistol range. We are proud of the facility, work hard to keep it up, and want you to have an enjoyable experience when visiting. Since we have new members joining all the time and it won't hurt any existing members to have a bit of a refresher about the range, we're happy to provide an overview of the range, our procedures, and how you can help us improve the Chapter's facility. Below is not an exhaustive list and it does not take the place of the Range Rules, but provides some guidance for things that often come up at the Rifle-Pistol range, a primer of sorts.

As always, please check the Chapter Web site for more information, along with the Chapter online calendar for range closures.

#### **Chapter's Range**

- We have a 17-position outdoor range for rifle and pistol shooting.
- Hours of operation:
  - » Summer—8 a.m. to 5 p.m.
  - » Winter—9 a.m. to 4 p.m.
- The range is open 363 days a year, closed on Christmas and Easter day.
- Target positions are at 25, 50, 75, and 100 yards.
- There is always at least one range officer (R0) on duty when the range is open.
- Cease fires are called on an approximately 30-minute schedule.

## **Upon Arrival**

- When you first enter the range, please find the RO, introduce yourself, and ask for an open lane.
- Sign in the log book
- If you have a quest:
  - » Please fill out the blue form completely. This includes the guest's name, address, and signature, and your signature as the member who is responsible for your guest's actions and conduct.
  - » Pay the \$10 quest fee.
  - » Exceptions to the quest fee:

- 1. If your guest is an immediate family member, a grandchild.
- 2. If your guest resides more than 100 miles from the Chapter.
- If you are new to the range, please take a few minutes to familiarize yourself with the range rules which are posted behind position 9. Feel free to ask the RO about anything that is unclear or if you have any questions about how the range operates.
- Please note, when on a cease-fire and the red lights are flashing, you are not allowed to handle firearms at all. This includes entering or leaving the range with a firearm, cased or uncased.
- Eye and hearing protection are mandatory at all times when the range is hot.
- The RO is there to keep you and the other members safe while on the range. If the RO asks you to do something, you must comply with their request because there is a safety reason behind what they are asking of you. If you argue, cause a disturbance, or disrupt range operations, the RO has the authority to direct you to leave the range.
- We allow only one firearm on the bench at a time.
   Please keep additional firearms cased, on the back bench, or in the provided rifle racks.
- Steel projectiles are not allowed at then range. In almost all instances, steel cases mean steel projectiles. If you bring steel cased ammunition, please show it to the RO on duty before shooting. They will use the magnet positioned near station 8 to determine if the projectile is magnetic. If the projectile is attracted to a magnet, you cannot shoot that ammunition at the range.

#### **Steel Plates**

The Rifle-Pistol range has had steel plates available for over 40 years, one of the first in the area to offer that option. We have recently been expanding the steel plate options and are excited with the program and hope to continue to expand this part of the facilities.

We have a few simple rules all members need to follow for their safety, the safety of other shooters, and the safety of our neighbors.

## **Use of Outhouses**

IMPORTANT: Septic tanks are used for the outhouses on the property. Trash (plastic bottles, bags, etc.) should never be disposed of in an outhouse for any reason. Trash clogs the septic tank and the Chapter has to pay to get it cleared. Groups may be charged these costs if the septic tank becomes clogged while they use the property.
