Chapter members are required to display their range badge when they access/use the Chapter's ranges. Access will be denied if you do not display your range badge. If you have lost your range badge, please contact the membership office to purchase a replacement



badge at https://wp.arlingtonfairfax-iwla.org/membership-general-information/. There is a \$10 fee for all replacement badges.

## **Bringing Guests to the ARL-FX Chapter**

Everyone has gone through the new member orientation, but you probably do not remember everything that was presented to you. We want to highlight some important information about classes of membership, displaying of range badge, and bringing quests to the Chapter.

#### Per the Chapter Bylaws:

#### **Classes of Membership:**

#### 1. CLASSES OF MEMBERSHIP

- b. **Regular Membership.** This is an individual membership with one membership card issued. ... (However, an additional adult living in the same residence and all dependents under eighteen (18) years of age may use the Chapter facilities when accompanied by the Regular Member.)
- c. **Family Membership.** This is a membership for two adults living in the same residence with two

membership cards issued. ... (All dependents under 18 years of age may use the Chapter facilities when accompanied by either Family Member.)

All range-qualified members are issued range badges and are allowed to bring guests to use the Chapter ranges. We are finding there are times when the Chapter rules are being broken and this is becoming a Chapter issue. Each year when a member renews their membership, they are issued a new badge insert with the current year's credentials. The old range badge inserts must be replaced by the newly issued one to ensure you are allowed access to the Chapter ranges.

- Members are not allowed to give their range badge or membership card or membership number to anyone.
- Copies of a membership card are NOT and will not be accepted as a range badge.

#### Per the Chapter Bylaws:

#### **Grounds Rules**

#### **GENERAL**

Any person using any facility or any portion of any part of the Chapter property shall do so at their own risk and by so doing hold the Arlington-Fairfax Chapter of IWLA, its Officers, Directors, Range Safety Officers, agents, and assigns indemnified from any personal injury or other claim.

- MEMBERS. Members, their spouses, dependent children/grandchildren under twenty-two (22) years of age, living in the same domicile, may enjoy the privileges of the property, while escorted by the member, but will be expected to properly identify themselves at any time if requested to do so by Chapter Officers, Directors, Range Safety Officers, or any member.
- 2. **DISPLAYING RANGE BADGES.** Adult Chapter range-qualified members MUST DISPLAY the current Range Qualification Badge in PLAIN SIGHT whenever they are shooting at any of the Chapter ranges.
- 3. GUESTS. Guests will be permitted use of the property only when accompanied by a member in good standing of the Chapter except as hereinafter provided for:
  - An individual may be a guest of a range-qualified member on the Chapter ranges five (5) times in

- one calendar year, except for special events or with prior permission of the Board of Directors.
- b. The number of guests each member may bring on to the Chapter property shall not exceed three (3) persons on any one day except with approval of the Program Director.
- c. **GUEST FEES:** Annually, in December, the Program Directors, with approval of the Board of Directors at a Board of Directors' meeting and recorded in the meeting minutes, are to define the guest fee for their program. Any changes will be implemented on January 1st.

For every visit to each range, the guest must complete a Chapter guest liability release form and pay any required fee.

• If the guest is a youth the adult member with that guest will be responsible for completing the release form.

It is very important you print clearly on the form. If we cannot read the form, you will be asked to complete a new one.

- Get first-hand knowledge of water quality in the streams monitored.



## Suman Sanghera Shatters Records at Junior Pan American Games

At the 2025 Junior Pan American Games in Asuncion, Paraguay, Suman Sanghera of Great Falls, Virginia, made a stunning mark on the shooting range, claiming Team USA's first gold in the shooting events and smashing multiple records in the process. In the Women's 10-meter Air Pistol qualification round, Sanghera set a new Junior Pan Am Games record with a commanding score of 57218x, surpassing the previous mark by five points. She continued her dominance in the final, achieving a record-breaking 237.2 points to secure the gold medal, outperforming silver medalist Sofía Ibarra of Mexico and bronze medalist Josefina Mella of Argentina. "It is an honor to raise the flag, and I am very proud to have represented my country well," Sanghera declared. Sanghera didn't stop there. She paired with Marcus Klemp in the Mixed Team Air Pistol event, and together they delivered a top-tier performance. Their efforts included setting a new qualification record in the mixed team category before clinching the gold medal in the finals.

Sanghera's South American success followed a string of triumphs in 2025.

- In January, she won the Camp Perry Open Senior and Junior titles.
- In March, Suman won the Collegiate Pistol Championship edging out her Pan Am teammate Klemp in the finals.
- In April, she finished second in the National Junior Olympics, barely missing the top spot by 0.1 points.
- In June at the USA Shooting National Championships, she finished second by 0.5 points in the Open Competition but bounced back to win the Junior title.
- In July at the Civilian Marksmanship Program Air Nationals, she took both the Open and Junior titles, setting a new Junior national record in the process. She also teamed with fellow NoVA Sharpshooters Elie Arkin, Will Regala, and Caroline Tso to win the Open, Club, and Junior team titles. Arkin and Tso also set new age-group records at the competition.

A BS-MD student at Case Western Reserve University, Sanghera has to balance training for elite-level competition with a demanding academic workload. Up next for her is the International Shooting Sport Federation World Championships in Cairo, Egypt, in November.






#### **Air Force Wounded Warrior**

Lt. Col. Christopher Dorough, one of several military wounded warriors who practice regularly at the Sills Air Range, won gold in Standing Rifle and Prone Rifle at the 2025 Department of Defense Warrior Games in Colorado Springs last month. Cheered on by his wife and daughters, Chris overcame a severe injury. The day before the qualifying match, he suffered a dislocated left elbow during the cycling race. The Air Force medical staff put him back together, just enough to compete in the qualifying round. Despite the pain and swelling, hundreds of hours of training kicked in, and Chris managed top scores in both Standing

and Prone Rifle, though the pain and discomfort certainly took its toll. By the second day of rifle competition, the swelling had subsided just enough to enable him to get into position for finals. The result, two gold medals for Team Air Force—while wearing borrowed Chapter gear! ## **NRA Woman on Target® Clinic**

If you were anywhere near the ARL-FX Chapter on Saturday, September 20, you probably heard it—women shooting everything from pistols to AR-15s, from compound bows to a wall gun. It was the Arlington-Fairfax Chapter's annual Women On Target® Instructional Shooting Clinic, and once again, the event was packed, with a record-setting 100% attendance rate with all 45 course slots filled.

This wasn't just a range day or a ladies' shoot. It was a full-on experience. New and returning participants took part in hands-on, one-on-one instruction in pistol, rifle, shotgun, AR-15, and archery, while also selecting among a series of seminars that brought context to their time on the range.

Retired Fairfax County Circuit Court Judge Richard Gardiner led two popular seminars — "Firearms and the Law" and "Legal Aspects of Self-Defense" — while two instructors presented curated sections of the NRA's Refuse To Be A Victim program, and still another led a seminar on how to select and care for your first firearm. Even lunch was educational, thanks to a guest speaker from the Virginia Department of Wildlife Resources, who connected the dots between shooting, conservation, and the Virginia Outdoor Women program.



Everyone's favorite part of every Women On Target® clinic is, of course, watching women grow in confidence as they receive individualized coaching on the line. Some were brand new shooters. Others were experienced members of groups like Armed Women of America, who came to try something new. Many found it invaluable to try out a new discipline or to check out firearms they were considering purchasing.

Highlights included busting first clays on the shotgun range, testing traditional rifles, including a historic wall gun, learning the flexibility of the AR-15 platform, and discovering a love of archery. Everyone left with a better understanding of what disciplines speak to them and in some cases, a new favorite.

This event doesn't just help women become better shooters—it can inspire good shooters to become great ones, and great ones to become instructors. This year marked a change in leadership as Sarah Smith took the reins from longtime Clinic Director (and current ARL-FX Chapter President) Pamela Meara.

Sarah's journey started just a few years ago helping out behind the scenes. "One of the first things I noticed was we needed more female instructors," Sarah noted. "I'm a lifelong shooter with a passion for training but I'd never married the two ideas. My father, an NRA Instructor himself, had encouraged me to do it for years – but it was Women On Target® that was the final nudge I needed. I jumped into training and certified in basic pistol and by the following year's Women On Target® I was on the line."

Clinic Coordinator
Lois Kellett has a similar
story. She attended her
first Women On Target®
clinic at ArlingtonFairfax in 2023 and left
determined to get more
involved. "I went home
and said – I am buying
a pistol. A month later



I had my Ruger Mark IV—the first of several pistols." Today, Lois is certified to teach several NRA disciplines and has been instrumental in forging a strong relationship between the clinic and her local chapter of Armed Women of America.

At its core, Women On Target® is about welcoming women into the shooting sports and into the organizations that host

## 2026 Season of the Chapter's Winter Skeet & Trap League

A reminder the 2026 season of the Arlington-Fairfax Chapter, IWLA, Winter Skeet and Trap League will begin on Sunday, January 4th, and run for 13 weeks.

The 2025 Virginia State Trapshooting Championship was held July 2-6 at the Winchester Gun Club and was well represented by the Chapter, where approximately 20 Chapter members shot at least one event, representing about one-fifth of all Virginia resident shooters.

Chapter members Virginia American Trapshooting Association Delegate George Hafkemeyer and 2nd Alternate Delegate Scott Petitto oversaw daily shoot-offs, trophy determination, and shooter classifications. Chapter trophy winners included Gregory Ricketts, Barton Bennett, Travis Rockwood, Frederick Wood, Dean Spiridon Jr., Alan Hemer, James Hickerson, Robert Nolan, Bennett Crandall, and Scott Petitto, several of whom won multiple trophies.

There were numerous other Chapter trophy losses by carry-over, shoot-off, or coin flip.

## **Outdoor/Indoor Archery**

## Arlington-Fairfax Chapter, Inc., IWLA, Archery 101 Classes



The Archery 101 classes will take place in the indoor archery range. This one-day class is designed for anyone who has never shot archery before or has very little knowledge of the sport and would like to see what our sport is all about. The

minimum age for children is nine years old.

The class will cover the different types of archery equipment, archery safety, purchasing of equipment, and live shooting. All equipment needed (bows and arrows) is available through the Chapter. All you need to do is register and show up.

## **Archery 201 Classes**

The Archery 201 classes are held at the indoor archery range. These sessions are held on five consecutive Sunday nights. There are two age groups, Youth ages 9-12 years old (5:30-6:30 p.m.) and Adult 13 years old and up, (7-8 p.m.) with a maximum of 11 students in each group. All archery equipment is provided so there is not any initial expense to participate. We also encourage the use of personal equipment if the student has already purchased it. The fee for the five-night class is \$150.

The class is taught using the USA Archery 11-step instruction model. We first concentrate on shooting form. Then we build upon this foundation with each lesson, so the student has the total archery shooting package by

the end of the session. Safety and range rules are taught the first night and reviewed before each class along with warm-ups and stretching. The class will cover the different types of archery equipment used, archery safety, purchasing of equipment, and live shooting. We try to have a 1:3 coach to student ratio so the student gets the best coaching we can provide.

#### **Archery 201 Schedule**


#### **Use of Outhouses**


