The 12 & 20 gauge championships were shot on Saturday. Club Member Doug Minning won the 12 gauge after a shoot-off win over Jim Hickerson. Junior shooter Mark Crowley won the 20 gauge crown after beating Al Talacek in a shoot-off of 98's.

Sunday morning found Jim Hickerson with a 99 in the 28 gauge, and he won the championship outright.

Sunday afternoon brought out the 410, and the good scores continued. The championship was won by Eric Bauer with a 96, followed closely by 95's from Mark Crowley, Fred Wood, Doug Minnig and T.W. Williams.

The win by Eric Bauer completed a 4 gun championship sweep by club members. The High-Over-All Open title was won by Fred Wood, while the 2012 Club Championship was won by Mark Crowley.

Kenny Savia won the 12 gauge Junior Title, Mark Crowley then started his run of Junior titles winning the 20 – 28 - 410 & HOA Junior Championships.

Ashly Palles won the Lady Championship Titles in the 20 – 28 & 410.

President's Column

I'm told I should say something about the tragedy in Newtown, Connecticut. Sorry, but I wasn't there. I don't know anyone who was there, and I don't even know anyone who lives there. I think I did drive through Newtown once, but that was over 20 years ago, and I don't remember much about passing through; although the scenery in that part of the country is truly magnificent.

My grandson, Harley, asked me how anyone could possibly shoot an innocent young child. I gave him the only answer that makes any sense to me: "Harley, that is the very definition of a madman. Only a madman would seek to harm little children". Harley thought for a moment and replied: "Yeah, I guess he was crazy". "No, Harley; he may have been insane, but he certainly knew exactly what he was doing. Insane, crazy and stupid are very different things. You need to remember that". And so do we all.

No, I wasn't there. I don't think any of our members were there. I didn't harm anyone. I don't think any of our members harmed anyone. And yet, somehow, we are being blamed. How does that work? Supposedly, we are to blame because we refuse to let those among us who are wiser than we pass gun laws which would disarm us. We refuse to see that if we were all unarmed, we would somehow be safer.

Well, how has that worked for us so far? If I remember correctly (Please check the facts and figures; but I don't think I'm very far off.), the "Gun Free School Act was passed some time around 1990. In the previous 70 or so years there had been about three (as in "3"; more than 2 but less than 4.) mass shootings on schools in this country. Since passage of that act, which made sure no law-abiding citizen would be anywhere near a school with a gun, the number of mass shootings at schools has increased steadily; and we are now averaging between six and twelve such incidents a year. So... how is that working out for you? And now we're being told that if we simply take away certain types of firearms from all the people, we would all be safer.

In September of 1994, Congress passed the so-called "Assault Weapons Ban". It was allowed to expire in 2004. We are now being told we should bring back the ban on semi-automatic rifles that look like military fully automatic rifles. Starting in 1994, did school shootings decrease? Or did they increase? They increased. When the ban was allowed to expire in 2004, did it make any difference in school shootings? No. So how can bringing back that law that didn't help then (And in fact, things got a lot worse very quickly), make things any better now; when it didn't help the first time around?

The killer in Newtown was 20 years old. By current law, he wasn't allowed to own any firearm. He was too young. By current law, he was disqualified from owning any firearm by his mental disorders. He was mentally incompetent. He stole the firearms he used in the shootings. He killed his own mother to get the guns he used. He took those guns into the "gun-free school zone". He fired the guns in an area where it is illegal to fire any firearm. He killed people. How many laws did he violate? I have no idea; but I don't think passing one more law for him to ignore would have deterred him.

On the Sunday after the shootings at Newtown, a man in San Antonio went into a restaurant to kill his girlfriend. After he shot her, most of the other people in the restaurant fled to a movie theater next door. The gunman followed. He shot a man in the parking lot and entered the theater. There, an off-duty lady policeman shot him four times and ended the problem. A good guy (gal, in this case) with a gun stopped a bad guy with a gun.

President's Column

One of these days, I'll assemble a 200 page list of Congressmen and Senators who advocate total gun control, but have no intention of turning over *their* guns. The famously anti-gun lady Senator who wants to ban ALL firearms, but carries a handgun in her purse which she has stated she has no intention of turning in. The other anti-gun lady Senator with the concealed carry permit. These people see no hypocrisy because they actually and honestly believe there **SHOULD BE** two sets of rules and laws; one set for them and one set for us. One law for the rich and powerful; another set for the common riff raff like us. Look into World History. In the days before there were firearms, weren't there laws that prevented the common people from carrying swords, or bows and arrows, or even knives; but which allowed the "nobility" to do so freely? And didn't our forefathers found this country under the concept that the law would apply equally to all people?

The simple truth is that there has never been, and will never be, a country on the face of the Earth where the rich, powerful and politically connected will not be able to own any firearm they wish. In Nazi Germany, in Soviet Russia, in modern China, the rich and powerful followed or follow one set of laws; the common people a different set. This country was supposed to be different; has always been different. We are about to find out if that will continue.

At Newtown the very worst of human nature was on frightful display; terrible rage and an uncaring and callous disregard for those little ones we should first and always protect. But please remember: Also on display by the teachers, the school staff, and even the children themselves, was the very finest of human nature; bravery, courage and self sacrifice. Let us never forget that. What happened in Newtown was terrible; an abomination and tragedy that never should have occurred. But I didn't do it; and I refuse to be convinced I am somehow to blame.

One thing I must admit: I do share one common trait with those who consider themselves to be our betters. Like them, I believe the only truly good guns are the ones which protect me and mine. And I plan to keep mine. Thanks; Ernie P.

Handguns and Holsters at Rifle-Pistol Range: No Concealed Carry

We have noticed several members and their guests in the past few months carrying handguns in holsters (concealed carry) while at the Rifle-Pistol Range. This is not permitted.

When can a member or guest bring a loaded handgun onto the Rifle-Pistol Range? The basic answer is **never**. All firearms brought onto the range must be unloaded and properly boxed, bagged, cased, or otherwise immobilized. (The only exception is for law enforcement officers who are on-duty.) Therefore no one may “carry concealed” while on the range. Also no one can “open carry” a handgun in a holster while on the range. All firearms must remain UNLOADED until authorized by the duty Range Officer when the range is “hot” or ready to fire.

The only place where a member or guest can fire a handgun is at the Rifle-Pistol Range. In effect, handguns are banned at all other ranges. We have had cases in the past where members fired handguns at a camping area or at one of the pavilions. This is very unsafe and cannot be tolerated!

To enter the Rifle-Pistol Range (inside the fence) all firearms must be UNLOADED and should be boxed, bagged, or cased. If you do not have a box, bag, or case then the firearm must be carried with muzzle pointing straight up and the action open. You cannot bring a loaded firearm onto the firing line of the Rifle-Pistol Range. You cannot bring a handgun onto the Rifle-Pistol Range in a holster (open or concealed). You cannot be at the firing line of the Rifle-Pistol Range with a handgun in a holster. And you cannot draw a handgun from a holster while at the firing line. The ONLY exception for holster carry, drawing, and firing of a handgun is during a NRA Personal Protection course operated by the Chapter Education and Training Committee when there are instructors present to monitor each and every course participant AND when the Rifle-Pistol Range is closed to all other shooting activity.

Also the Rifle-Pistol Range safety rules prohibit any loaded firearm during each cease fire period and require all firearms to be benched with actions open. A holstered handgun would be loaded, action closed, NOT benched, and the muzzle NOT pointed in a safe direction. Furthermore, the cease fire rules prohibit “handling” of any firearm during the cease fire. A person with a holstered handgun would be considered as “handling” that firearm!

All of the above is a reminder to All MEMBERS (and, therefore, their guests) to practice safe firearms rules at all times and to obey the chapter and range safety rules. Members who willfully violate these rules can be suspended or expelled from chapter membership. **SAFETY FIRST, LAST, AND ALWAYS.**

Winter Weather Policy

Our winter weather policy: **If the weather is bad enough that Fairfax County closes their school system, then the Rifle-Pistol Range is automatically closed.**

The second part of our winter weather policy is common sense. First, all of the range officers are volunteers. Some of them live a far distance away from the chapter. One comes from Pennsylvania, another from Front Royal, and a third lives closer to Richmond than the chapter property. In bad weather they may have more snow than we do or worse road conditions than we do. I do not expect them to endanger themselves just to get to the range and open it. Second, there may be conditions that prohibit them from making their duty time. They may be sick, or a spouse or child may be ill and they have to stay home.

In the last big storm we had two feet of snow on the ground at the range. One could not even find the target lines to place the target frames. Yet some member came out and complained rather vocally that he wanted to shoot and where in #S%&* was the range officer and why wasn't the range open! I think under these circumstances common sense would tell the irate member that the range was not open BEFORE he even left his driveway! I am reminded that common sense is not commonly available.

In 2012 a total of 907 target frames were repaired by a handful of volunteers. This averages 2.5 frames for every day the range is open

This is a great time to come down and introduce yourself and find out what Cub Run Archers is all about. If you are new to archery and need advice on anything from bow setup, arrow tuning to shooting technique, not only will you find literally, several hundred years of collective experience, but equipment to perform those tasks. We especially would like to encourage youth participation and have a great many youth bows that young shooters may practice with to develop their skills. The cost to join Cub Run Archers is only \$15 per year. Though you don't need to be a member of Cub Run Archers to use the facilities, we have a monthly newsletter and several dinners and picnics throughout the year and attendance at even one of these would easily be worth the annual membership. The outdoor facilities are available to any members in good standing of the IWLA. We have a practice range with target butts at 5, 10, 15, 20, 30, 40, 50, and 60 yards. These are lighted as well if you would like to shoot in the evenings. There is also crossbow station with a movable bag target for field points only and a broadhead target for broadhead shooting. Remember, crossbows are allowed ONLY at the special crossbow station and not at any of the other targets or ranges. A 28 point field archery course is also available for use to all IWLA members. Daytime use only as there is no lighting on the field course.

Indoor Archery Range Open for Evening Shooting

The indoor archery range is open for evening shooting through the end of March, 2013. The range will be open for evening shooting Monday, Tuesday, Wednesday, and Thursday evenings 6:30pm till 9:30pm. All IWLA members are welcome to use the range. This is an excellent opportunity for all you Fairfax County bow hunters to keep your shooting at peak performance throughout the hunting season.

Cub Run Winter Classic

If you shoot a bow, you will not want to miss this event. On Sunday March 10th our yearly 3D winter classic shoot will take place on our 28 target outdoor range. This is a scheduled VBA shoot. Registration is between 9am and 1pm for all shooters. This shoot is open to all, make it a family day. Our kitchen will be open to serve hot sandwiches, chili, and snacks for a small fee.

Cub Run Field Hunter Shoot

2013 Winter Skeet and Trap League Now Underway

The 2013 winter skeet and trap league season kicked off on 6 January with a full field of 28 teams and 168 shooters. The season runs for 13 weeks, wrapping the week after Easter. With the weather guessers unable to accurately forecast snowfalls, we are all hoping that shooting can be accomplished without disruption as we experienced last year. Shooting in snow is OK, driving in the snow is not!

The weather cooperated for the first day of the season with temperatures in the mid 40's and light winds. Doug Minnig recorded the high score of the day with a perfect 50 in Skeet, but Andrew Poloni came in close behind with a 49. Bob Baublitz had the high Trap score with a 49 followed by Tom Anhalt and Sooho Ham with 46's. It's a long season, so only time will tell who ends the season as Top Guns, but these folks are off to a great start.

Team awards are again being determined in two distinct categories: weekly match point competition between two teams; and cumulative team score over the entire season. The first category rewards the ability to prevail in head to head match ups each week, while the second category rewards consistent performance over long haul. The standings with only one week down resulted in a two way tie for First Place in the match competition category between teams 19 and 20. Team 19 also topped the list in the team score category, with teams 27, 21, 16, and 10 rounding out the top five places.

In preparation for the start of the season, many league members volunteered their time on New Year's Eve to accomplish the myriad of chores around the range that support league activities, including loading boxes of targets into the trap houses to grounds maintenance to firewood collection to general housekeeping in the clubhouse. Since the winter league goes through in excess of 100,000 targets over the course of the season, keeping up with the chores requires constant attention. Pete Bills once again has taken the initiative to organize and direct the work, so special thanks go out to Pete. Thanks also to everyone who pitched in to help get ready for the start of the season.

Welcome to the shooters new to the league this year and welcome back to all the old hands. Keep your head down, your eye on the target and be safe!

Work party readies skeet and trap for winter league kick off



I've been mentioning for more than a year some changes expected on the membership front. One of those changes is to make the late fee for renewals start when the membership actually runs out, which is 1 January of each year. This will encourage people to get their memberships in on time instead of waiting until almost 1 March, which is also when the new member crunch begins. We really would prefer to have people who expect to renew have done so prior to the start of classes each year. This also makes the penalties a two step process; a small penalty (a late fee) if you renew after 1 January. A larger penalty (your place is up for grabs from the new members) after 1 March. Many of you know people who tried to renew late, only to find themselves out of luck as we had already filled for the year.

The second change we are considering is setting the late fee to be 20% of the renewal cost. For example, if your renewal would be \$180 as a regular member, your late fee would be \$36 if you wait until after 1 January to renew. When originally written into the rules, the late fee was about 25% of the regular member renewal fee. Since it was written in as a fixed amount instead of a percentage, it has not kept pace with inflation over the decades, and late renewals have become extremely common.

An interesting effect I hope to see from these changes is a slight reduction in payments to the Chapter. Why? Because more people will renew on time, and we will make less money on their late fees. These changes would be expected to start with the 2014 membership season, after being voted in as changes to the bylaws during 2013.

We still expect to see between two hundred and three hundred memberships cycle each year. For those of you having friends wanting to join, remind them to submit their email requests through the web page to get on the waiting list. We still expect to have enough openings in 2013 for the people who have requested slots so far (as of 4 December 2012 when I am writing this). Take care and everyone have a good Holiday season.

Get Anyone Interested in Joining to Contact Us via Email

For those of you with friends who want to join, they need to send me an email to get onto the reservation request list. As I write this the first week of January 2013, I have over 230 people who have contacted us to join the club. That is before addressing the remaining 88 unopened email requests I see before me today (many of which are follow-ups on previous emails). If your friends want to join this year, they need to get their requests into the system. As always we expect between 200 and 300 openings for new members in 2013. The longer they wait, the more the odds become stacked against them being able to join this year before we hit our membership cap of 2200 memberships.

You will be seeing new members starting in late March 2013. They will have those rectangular temporary badges. Please remember to work with them on learning our procedures. They are not allowed to bring any guests onto the ranges while they have temporary badges. This rule has been emplaced to ensure they have a chance to learn our range processes and procedures before bringing any guests.

Since you are reading this in February 2013 or later, you have hopefully already sent in your signed renewal form with your payment for the 2013 Membership Year. If you have not received your renewal after six weeks, please contact the Administrative Assistants (Scott or Linda) at 703 631-4495 to confirm you are in the system. The renewals are mailed out in batches of three hundred or more as part of our using bulk mail to save money. That in turn can lead to delays in when people get their cards and replacement stickers.

There will be a meeting of the membership to vote on various changes to the bylaws for the club. One of the changes I am proposing is to make the late fee a standard 20% of the annual renewal cost by membership class. The late fee would also be due for any renewal postmarked or received after 1 January of each membership year. This way the late fee is automatically indexed against the membership cost, and it provides a two stage "penalty" for late renewals. If you are late (after 1 January), you pay a fee. If you are real late (after 1 March) you are dropped from rolls. As the numbers discussed earlier illustrate, there are plenty of people who would like your slot if you are late. This also ensures the pulse of new members that begin in March each year does not conflict with a pulse of renewals from people waiting until the last instant of time to do their renewal. I ask you to vote in favor of these changes.
