1. **CALL TO ORDER** The meeting was called to order at 7:30 PM by President, Tom Ciarula.

2. **MEMBER TIME**

3. **PRESIDENT'S TIME**

- Nothing to report.

4. **MINUTES/CORRESPONDENCE**

- Minutes from the July 2021 General Membership Meeting were available for all to review. Mr. Ciarula corrected the minutes to state the \$6,000 requested in 1970 for a field house with a 6-foot porch was for Skeet/Trap.

5. **TREASURER'S REPORT**

- Mr. Crisman presented the Budget Report through the end of July 2021 to the Membership.
 - Income: \$348,628.72
 - Expenditures: \$173,003.08
 - Balance Remaining: \$175,625.64

6. **MEMBERSHIP UPDATE**

- Mr. Crandall provided an update on status of the Membership, stating that the Chapter currently has 2,203 memberships accounted for. Mr. Crandall stated that the last time the Chapter had 2,200 memberships was in 2015.
- Mr. Crandall moved to accept the candidates from the August New Member Orientation (those in attendance and those who were not able to attend) be voted into the Chapter. The motion was adopted, and 41 new members were admitted to the Chapter.

7. **SPECIAL COMMITTEES**

- Building & Grounds
 - Mr. Hicks stated that asphalt millings have been successfully applied to the Chapter roads.
- Youth
 - Mr. Turner stated that the Youth Board of Directors will be installed later in the meeting.
 - Mr. Turner drew the raffle for a Glock handgun after 200 tickets had been sold. The winner was James Repass. \$4,000 was raised for youth activities at the Chapter.
- Field Archery
 - Mr. Riemer stated that the Field Archery range is very busy with deer season starting soon, and that Archery 101 classes are always full.

- Target Archery
 - Mr. Riemer stated that Jeff Delvecchio is now accepting applications for participation in the upcoming Junior Olympic Archery Development (JOAD) Program.
 - Mr. Riemer also stated that they are seeking additional archery instructors.
- Air Range
 - Mr. Kuck stated that the Air Range recently held several successful clinics.
 - Mr. Kuck reminded those in alternance that the Air Range is open on Mondays and Fridays for public use, and that reservations are required via SignUpGenius.
 - Mr. Kuck informed the membership that Lucas Kozeniesky won a silver medal at the recent Tokyo Olympics in Mixed 10 Meter Air Rifle Team.
- Rifle/Pistol
 - Mr. Frerking informed the Membership of upcoming events at Rifle/Pistol, including a service rifle match, Bull Run muzzleloaders, and short range day.
 - Mr. Frerking stated that there are two ongoing/long-term projects occurring at Rifle/Pistol.
 - The use of steel and reactive targets is being reassessed.
 - Baffle and roof replacement at the Rifle/Pistol range. Mr. Frerking stated that an architecture firm has recently been hired to design the range updates. The plan is to replace all of the baffles and roof, re-align the supports to increase shooting spots, and create a shorted backstop to allow closer targets for 1/3 of the range. Mr. Frerking also stated that 3 action pistol bays are proposed.
- Historian
 - Ms. Goodenough stated that in 1971, prospective new members has to attend a Board meeting an explain their intentions to join, and were then voted in at the following general membership meeting if approved.

- A member inquired on how to use the Shenandoah property for hunting. The member was directed to the Chapter website for information on facility use requests.
- A member inquired on the process for installing a new Vice President now that the position is vacant. The member was informed that a new Vice President will be appointed at the September Board of Directors' meeting in accordance with the Chapter Bylaws.
- Mr. Ansick reminded the members that badges are to be worn on all of the Chapter ranges. Mr. Kuck stated that the Air Range is frequently open to the public, and that there are times when participants will not have range badges.
- A member stated that a friend of his recently purchased a skeet range in Paeonian Springs, Virginia and that he has two trap machines offered for sale. Mr. Crandall informed the member to reach out to Mr. Bob Brino, director of Skeet/Trap.
